PRODUCT DESCRIPTION

Quick frozen dates are made from fresh, clean seeds of the "Madjhul" Dates & Deglet Noar. Production process includes picking, Heat treatment, freezing, sorting, freezing, and is made to ensure the cleanliness and stability of taste, smell and color. Product's temperature should not exceed – 18 °C when leaving the factory.

Color – uniform fresh ripe fruit color, typical of the product.

Texture- uniform typical of fresh ripe fruit. Odors- typical of fresh ripe fruit, no stale, "off" or musty /fermented odors.

Assessed on two samples of 50 dates from each pallet:






